## ***Privacy Policy in Compliance with Art. 13 of Legislative Decree 196/2003, and following the entry into force of EU Regulation n° 679/2016***

In compliance with the provisions of Legislative Decree 196/2003 (Codice in Materia di Protezione dei Dati Personali or the “**Code**”) and of (EU) Regulation 2016/679, (hereinafter referred to as the “**Regulation**”), please find herein some information on the processing of personal data, for the purpose of registering online to participate in the events organised and managed by Fondazione Italiana del Notariato.

### **PURPOSES**

The personal data you provide us shall be processed, in compliance with the aforesaid rules and regulations and with the relevant confidentiality obligations, for the following purposes:

- a) To fulfil the obligations deriving from the contractual relationship with Fondazione Italiana del Notariato (including, for instance, processing your Congress, Conference, Workshop, and workshop training session registrations; publishing – including via online streaming, audio and video recordings of Congresses; for bookkeeping, invoicing, and credit management purposes; in order to fulfil civil-law and tax obligations provided for by the law; and for the updating of our personal records);
- b) With your consent, in order to disseminate information, for documentation purposes and to promote the event and the activities carried out via the Fondazione’s official channels (for the mailing of information on future Congresses, commercial promotions, and market surveys), via e-mail, SMS, MMS, fax or else, or by post or telephone.

### **LEGAL BASIS**

The legal basis for processing is the following: for the data processed for the purposes referred to in paragraph a) above, the fulfilment of the contractual relation between you and Fondazione Italiana del Notariato, or the fulfilment of statutory obligations; for the data processed for the purposes referred to in paragraph b), your expressed consent.

### **TYPES OF DATA PROCESSED**

When registering online, users are asked to type in some personal data (such as name, date of birth, and contact details). The personal data provided by the users who register online shall only be used by Fondazione Italiana del Notariato to provide the requested services. Please be informed that you may be asked to provide your bank details or other information concerning the method of payment. Such information – which is required when the need arises to pay a fee – may be communicated to third parties for purposes exclusively related to the execution of the contract.

For the execution of the contract, it may be advisable and/or necessary for users registering online to also provide some sensitive data (including special dietary needs due to food allergies and/or intolerance, or to any physical limitation or handicap). Should the user not provide such sensitive data, or should he/she not authorise its processing, Fondazione Italiana del Notariato shall not be able to guarantee the quality of the service provided to the user.

The personal data provided may be used for additional purposes, such as information on future congresses, commercial promotions, and market surveys. Such data shall be used for the above-mentioned purposes only, with the expressed and explicit consent of the person concerned.

The provision of data for the purposes referred to in paragraph b) above is optional.

### **PROCESSING METHODS**

Your data may be processed **electronically** or by means of **automated tools**, as well as through **non-automated** means (including paper archives). Data processing methods and tools shall be such as to ensure the security of the data.

### **PEOPLE AUTHORISED TO PROCESS DATA**

Your personal data shall be accessible to the Fondazione's personnel, tasked by the processing Controller and/or the Processor to process it. The Controller may disclose, for the same purposes, part of your personal data to third parties, which shall process your personal data in their capacity as Processors. You may ask the Controller for the Processors list.

### **DATA DISCLOSURE**

Your personal data may be made available to:

- a) Private citizens, agencies or consortia that provide processing services, or carry out activities required for the provision of such services, for purposes that are closely related to the contractual obligations;
- b) Entities that require your personal data to manage the contractual relation, such as banks, professional firms, etc.;
- c) Entities that are entitled by law, by second-level provisions, or by EU regulations;
- d) Social-security agencies, including any entity referred to in the Agreement, and Public Administrations, with a view to fulfilling statutory obligations.

Your personal data shall not be disseminated.

### **DATA STORAGE**

Your personal data, collected for the purposes listed in paragraph a) above, shall be stored for a period of time covering the duration of your contractual relationship with the Association that is the processing Controller and, anyway, for civil-law, accounting, and tax purposes, for at least ten years after the end of the contractual relationship.

Your personal data, collected for the purposes referred to in paragraph b) above, shall be stored for a period of no longer than twelve months as from the moment it is stored.

### **RIGHTS OF THE DATA SUBJECT**

You can exercise the following rights, which are set forth by Legislative Decree 196/2003 and by Article 15 and following ones of EU Regulation 679/2016:

- ✓ To get confirmation as to whether or not personal data concerning you is being stored, and being communicated what that data is about in an understandable form;
- ✓ To know the origin of personal data, the processing purposes and methods, and the rationale applied in the event that the data is processed electronically;
