Integration, Migration, Transnational Relationships. Governing Inheritance Statutes after the Entry into force of EU Succession Regulations

Background: The purpose of this report is to measure the strengths and weaknesses of the Online Hungarian Seminar of the *GoInEUplus* project, which took place from June 24 to July 2.

The training event, which replaces the seminar canceled in April due to the containment rules for the spread of Covid-19 disease, was divided into **two modalities**: deferred and live streaming.

The recording of the presentations in Hungarian and of the round table in English was made available in deferred streaming from **24 to 28 June 2020** on the following e-learning platforms: MOKK (Hungarian Notary Chamber), MIA (Hungarian Magistrates Training Academy) and MÜK (Hungarian Bar Association).

Workshops on practical cases to be solved in small groups of 25 participants in Hungarian language have been delivered on live streaming. The live streaming was held on **29, 30 June 1st and 2nd July 2020**. The participants were able to choose freely one of the proposed dates to access the platforms.

Questionnaires: at the end of the event all the participants were invited to fill in the online evaluation questionnaire.

The questionnaire aimed at identifying the critical aspects of the event we organized to improve its quality in the future. It has been foreseen to have answers both multiple-choice questions as well as some open questions set to collect general comments on the event.

Executive summary: On a presumed number of 120 participants, of which in fact were a few around 340 participants¹, we received **104 completed questionnaires**. A percentage that is around **30%** of the participants and taking in account the situation of this event makes the sampling numerically interesting for the survey that was required.

From a general point of view, the seminar was understood and appreciated by most of the participants. More than **7 out of 10 participants answered more than positively** to understanding the purpose of the initiative (Degree of satisfaction: *a lot, very much*).

Another significant result emerged from the analysis of the questionnaires completed is the high approval given by the participants with respect to the capacity and quality of the speakers. Prized particularly for the good knowledge and competence of the subject.

The quality of the material was appreciated by the participants (e.g. majority of answers *A Lot*), it emerged the need to managing the part of materials made available to the participants. As happened for the other Seminars *GoInEUPlus* this suggestion will certainly be taken into consideration for the upcoming events.

Training

1.Objectives

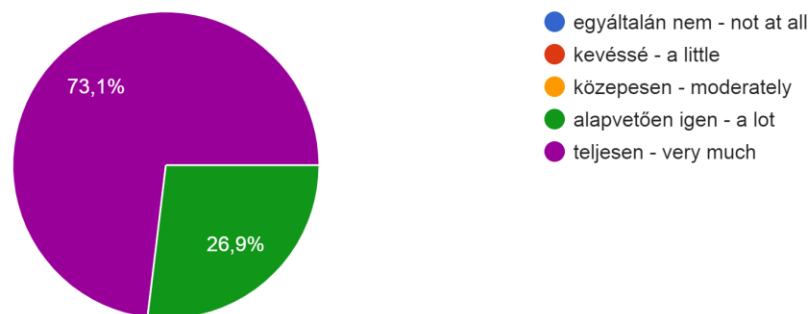
Question: How clear is the aim of the event (training and exchange)?

- 73,1% of highly positive answers (box *very much*)
- 26,9% *a lot*

2 Content

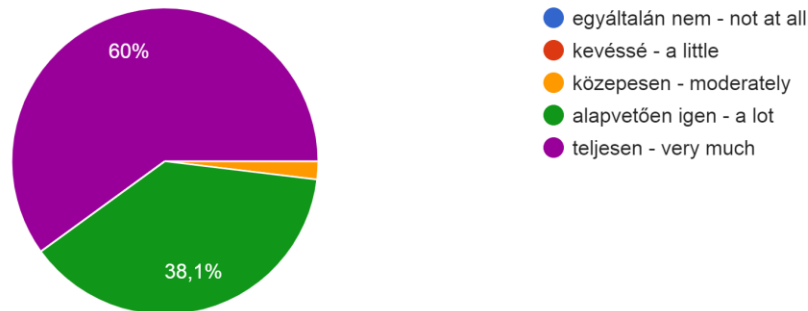
Question: Did the content of the event (subjects addressed) satisfy your expectations?



The subject treated has responded to the expectations of the target audience: unanimously satisfied the participants (*Answers a lot and very much*)².

The theme and the project are of interest to the public and the recipients to whom it is addressed.

- Only around 4% of respondents moderately appreciated the combination between the subject and the didactic tools used.

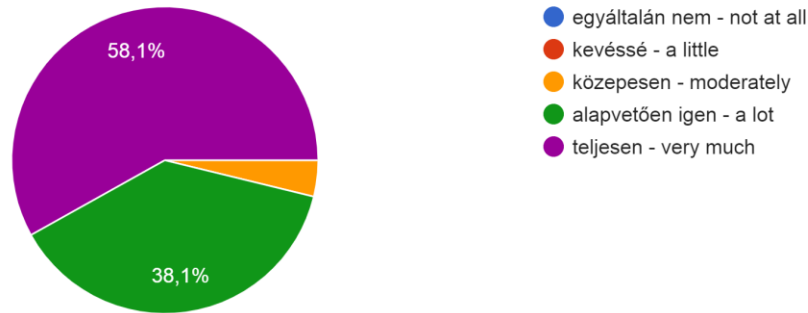

- the instruments that they used for their presentations.

The question was introduced for receiving useful feedback from the participants on the two principal tools used to facilitate their understanding and learning. Consequently, the choice for the answers were structured in three different options⁴:

- Effective*
- Not effective*
- Not applicable*

Comparing the answers on the two proposed tools, we noticed a predominance in favour of slides presentations.

In fact, close unanimously the participants have positively evaluated the offer (*presentations/slides*). Confirmation that even for a qualified audience such as that of the legal professions, a text and a presentation accompanied by video or visual presentations is much more appreciated and admissible.

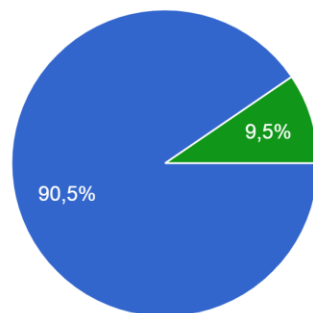

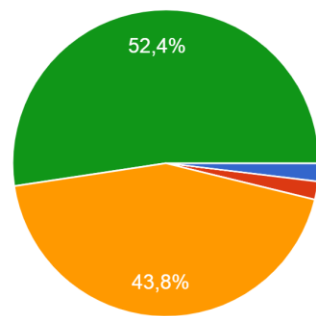

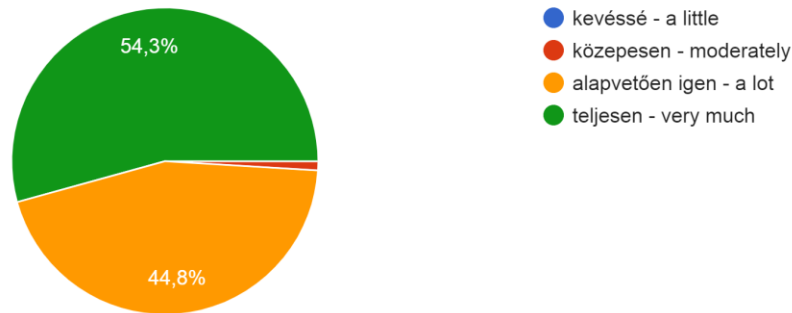

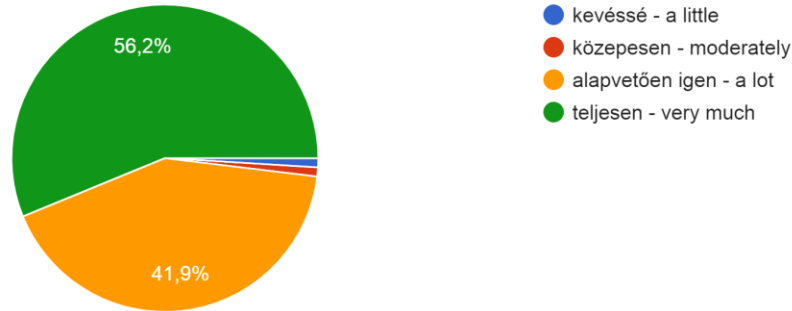

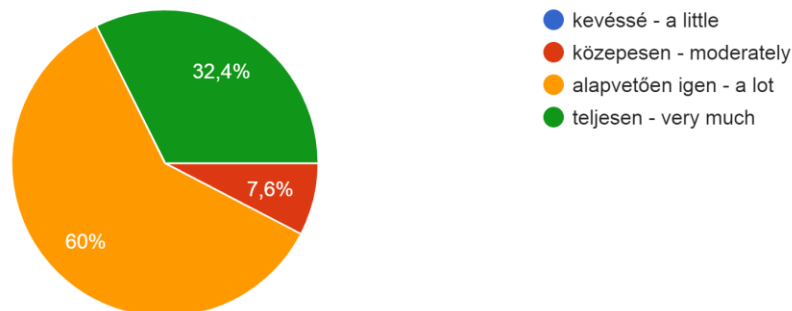

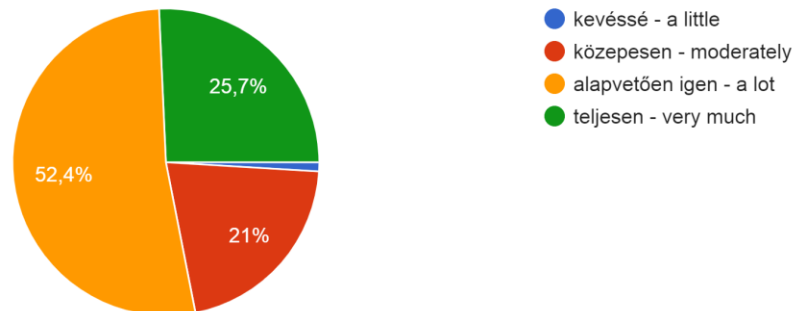

As for the other past events this is the most important part of the questionnaire. The measure of the answers given by the meeting to the expectations and the professional and academic needs of the participants.

Regarding the first question, the responses were highly positive for more than 92% as *very much* and *a lot*. This confirms that the profession of the participants is largely the correct target set by the project

For the second question, more than 78% of respondents answered positively. This is even more interesting, as the wider part of the participants recognized the added value of the initiative from their professional point of view.

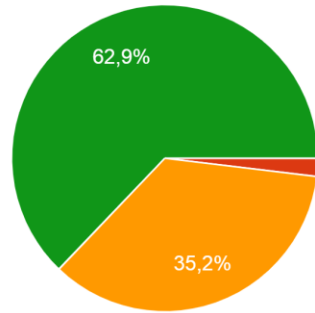

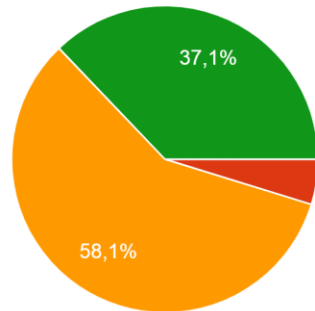

Globally a positive view. More than of participants responded that the material was distributed in a simple and quick manner (98%) and well covering all the aspects of the subject addressed (95%)

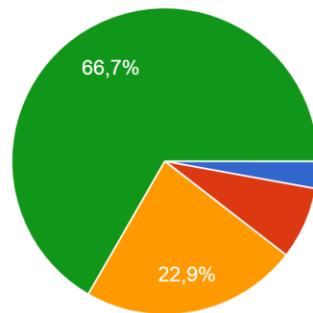

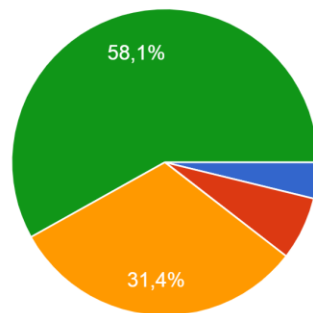
